## FEEDBACK ON THE MASTER PLAN PROCESS:

- Save more open space
- Keep Duxbury like it is!
- Remove suggestion for three stories in business districts Scituate Harbor is now an ugly canyon on Front Street
- Encourage the development of bike paths in order to bring greater economic development and better safer and less polluting transportation
- Preservation of open space
- Describe how the town can best use and maintain the comprehensive plan ... who owns it? How do town committees and agencies use the plan? How should/could the Town update and maintain the plan?? Should town committees and agencies be required to address the comprehensive plan as they review and permit processes ... housing, open space, historic and cultural, etc.

## FEEDBACK ON PHASE 1 ELEMENTS (HOUSING, OPEN SPACE, HISTORIC AND CULTURAL RESOURCES):

- Biggest frustration of people I talk to is the fact that Duxbury is losing its old housing stock to BIG TROPHY HOME. <sup>(2)</sup> People are <u>not</u> putting their homes in an historic district. I think there are too many restrictions on homes in an historic district. (Might be the reason people aren't doing it.) Duxbury needs a "Harbor Plan" stretching the whole length of the waterfront and in two miles. All the homes in this district should be saved.
- I am concerned about the emphasis on sidewalks. Won't this run counter to the rural and historic character of the town? How do you make walking safe without "suburbanizing" the townscape?
- Excellent

- We need more affordable housing!
- We need more affordable housing, we need to figure out how to have a vehicle that prevents tear downs of historic homes and the building of mcmansions!
